Dear Colleagues,

It is my pleasure to herewith officially invite you to the XXV Ordinary General Assembly of the European Shooting Confederation that will take place in Ljubljana, Slovenia, on July 18-19, 2015 in the "Austria Trend Hotel Ljubljana".

You will also find enclosed the GA Registration form. It should be filled in and send to the attention of Mrs. Elvira Valant, by e-mail ga2015@ech slo.eu or by fax + 386.1.4280583.

There is a certain number of rooms booked by the ESC in the "Austria Trend Hotel Ljubljana" for the participants of the General Assembly. The deadline to determine the exact amount of the required accommodation is June 14, 2015. So, those of you who will prefer to stay in the "Austria Trend Hotel Ljubljana" must fill in and send the Registration forms before this date.

For those of you who need visa to come to Slovenia special arrangements will be done after you complete the GA Registration forms. That is why we ask you to complete the GA Registration forms at your earliest convenience.

Let me remind you that the ESC Statutes determine the norms of representation of National Federations at the General Assembly:

- According to Art. 5.8, one federation representing all shooting sports will have two votes and may be represented by one or two delegates;
- According to Art. 5.9, if a country is represented by two federations, each federation is entitled to one vote and one delegate;
- According to Art. 5.10, member federations may be represented by proxy, given in writing. One member federation may not represent more than one other member federation. Member federations with one vote may only hold one proxy vote. Member federations with two votes may hold two proxy votes.

The National Federations applying for the European Championships 2018-2019 are welcomed to make presentations at the General Assembly. However, such presentations should have a maximum length of 5 minutes and should be handed over to the ESC Secretariat on July 18 at 14.00 latest.

The minutes of the proceedings of the XXV Ordinary General Assembly of the European Shooting Confederation will be sent to the Member Federations within two month after the meeting.

I look forward to welcoming you all in Ljubljana.
