**3. RULES AND REGULATIONS**

All information, Rules and Competition formats for the ESC Championship can be found on the ESC website: <https://esc-shooting.org>.

The Juries (Competition Jury, RTS/ Equipment Control Jury) have been designated by the ESC to supervise the Championship. Qualified Referees/Range Officers holding the applicable ISSF Licenses will conduct the competitions.

**Rifle / Pistol Equipment**

Equipment Control will be conducted according to **ISSF Rules** using approved, calibrated instruments. All athletes are strongly encouraged to submit any doubtful equipment or clothing to Equipment Control for inspection prior to the competition. All athletes are subject to random post-competition testing; disqualification will occur if equipment or clothing is found to be non-compliant with the ISSF Rules.

All **pistols** must be **registered** in the ISSF **database**. Any pistols that have not been previously registered or recorded must be checked for compliance with ISSF Rules and registered to the athlete.

**Rifle Clothing**

All rifle athletes must have **ISSF Seals** with serial numbers affixed to their jackets, trousers, and shoes. Any jackets or trousers lacking **ISSF Seals** must be submitted to Equipment Control for inspection.

Please note that all existing **ISSF** seals and Equipment Control cards/certificates issued for jackets and trousers will become invalid as of **1 January 2026**. All clothing items must be submitted to Equipment Control for testing.

Athletes looking to replace a registered jacket or trousers with a new item must bring the new item to Equipment Control for inspection and the issuance of a new seal. Previous seals will then be cancelled.

Rifle athletes are permitted to have only **one (1)** active **jacket** and **one (1)** pair of **trousers** at any given time.

## Shotgun Equipment

All skeet athletes must have ISSF seals with serial numbers on their marker tapes. Any shooting vests that do not have ISSF seals on the marker tapes must be submitted to Equipment Control for inspection and the affixing of a seal before the competition.

## Equipment Control

Will be conducted according to the **ISSF Rules** using approved, calibrated instruments. Pre-competition testing is not mandatory; however, athletes are responsible for competing with legal equipment and clothing. All athletes are urged to submit any doubtful equipment or clothing to Equipment Control or the Shotgun Jury for checking before the competition. All athletes are subject to random testing during the competition. Athletes found to be in violation of the rules for guns or skeet marker tape will be disqualified.

## Cartridge Controls

During the competitions, athletes whose cartridges are to be tested will be selected by a computer draw. Between 10% and 18% of athletes participating in an event will be selected for cartridge testing. **Two (2) plus four (4)** cartridges will be taken from each athlete placed in separate labelled envelopes.

The **two (2)** cartridges must be tested first. If both cartridges weigh 24.50g or less, no further action will be taken. If one or both cartridges weigh more than 24.50g, the **four (4)** cartridges in the second envelope must then be tested. If the average weight of all **six (6)** cartridges exceeds 24.50g, the athlete will be disqualified (DSQ).

In accordance with ESC rules, the Jury may also decide to conduct cartridge controls during the Final stages of each event.

## Coloured Wads

Only transparent or translucent wads with no color may be used.

**Any athlete found using ammunition that does not comply with ISSF Rules will be disqualified (DSQ).**

## All Post-Competition Testing

All post-competition testing will be conducted in accordance with ISSF Rules.

## National Identification/Dress Code

The athletes from each nation must display their national identification on their shooting clothing as follows:

**Rifle:** The country name must be denoted by the **three-letter code** determined by the IOC. This must be displayed on the jacket pocket facing the audience. If the NOC code is already present on the shooting jacket, a National Flag must be placed on or attached to the pocket facing the audience.

**Pistol:** The country name, denoted by the **three-letter IOC code**, must be displayed on the sleeve of the T-shirt or sports jacket on the side facing the audience.

**Failure to comply** with the dress code may result in the athlete being **disqualified** from the competition.

## 4. PARTICIPATION

### Individual Events

ESC Member Federations may enter a **maximum of three (3) athletes** in the **Individual** events.

### Team (as per ISSF Rules)

Only **three (3)** athletes from the same gender may be registered as a team. Teams must be officially declared during the **REGISTRATION PROCES** in accordance with ISSF rules. A maximum of **one (1) team** per **Member Federation** is permitted.

### Mixed Team

ESC Member Federations may enter a maximum of two (2) teams.

## ESC CHALLENGE EVENTS

### Solo Shotgun

Each nation may enter a maximum of **three (3)** athletes in each Solo event. The participating athletes are determined by the Final Ranking of the respective Individual event, in accordance with the rules. The format of the Solo competition consists of duel/elimination matches. The number of elimination stages will depend upon the total number of participating athletes.

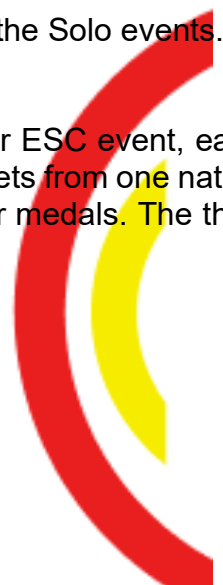
### Solo R/P

ESC Member Federations may enter a maximum of three (3) athletes in the Solo events.

### Duet Events

ESC Member Federations may enter a maximum of **three (3) teams** per ESC event, each consisting of one (1) man and one (1) woman. A maximum of **two (2) Duets** from one nation (registered as Duet 1 and Duet 2) may qualify to compete in the Final for medals. The third team (registered as Duet 3) is ineligible to qualify for the Final.

No **Mixed-Nation** pairs are permitted.

**ID Number**

All athletes must have an ID number. This may be either an **ISSF ID** or an **ESC ID** obtained during the registration process.

**Age Eligibility**

In accordance with Article 11.5 of the ESC General Regulations, athletes may compete in U23 European Championships until 31 December of the year in which they become 23 years of age. Therefore, for the 2026 U23 European Championship, all athletes born on or after **1 January 2003** are eligible to participate.

**RECORDS**

Only **European Records** may be **established** at this competition. **World Records** will not be recognised.

**5. ENTRY PROCESS**

Please complete the attached Registration Forms (Annex 2 - 9) and return them by the established deadlines.

Preliminary and Final Entries for Athletes and Officials must be submitted via the ESC Entry System.

All other Registration Forms must be returned to the Organising Committee (see also "Summary of Deadlines").

**Preliminary Entries**

ESC Member Federations entering the Championships must submit the Preliminary Entries no later than **2 JUNE 2026**.

**Final Entries**

ESC Member Federations must forward their Final Entries directly to the ESC. The Final Entry Deadline (30 days before the Official Arrival Day) is **2 JULY 2026**.

**Late Entries**

If the maximum number of athlete entries has not been reached, late entries will only be accepted until the Late Entry Deadline (three (3) days before the Official Arrival Day) which is **28 JULY 2026**.

**Important Note:** Until the Late Entry Deadline (three (3) days before the Official Arrival Day), the following changes to the final entries are permitted without restriction or additional fees: Change of names/Athletes within an event.

All Team Leaders of ESC Member Federation Delegations must report to the OC Entries Official and confirm their **Final Entries**. This confirmation must be completed no later than **12:00 (noon)** on the day before the Technical Meeting.

**ENTRY CHANGES AFTER THE LATE ENTRY DEADLINE**

From **29 JULY 2026** onward, only the following changes in the Final Entries are permitted:

- a) **Replacement of an athlete: A registered athlete may be replaced by another athlete who is already registered for another event. This replacement must be completed no later than 12:00 (noon) on the day before the Pre-Event Training for that specific event.**
- b) **Additional entry due to medical reasons: An additional entry is permitted only if a registered athlete is unable to participate for medical reasons. This change must be reported no later than 12:00 (noon) on the day before the Technical Meeting.**

**Cancellation**

Any ESC Member Federation that reduces the number of athletes listed in their Final Entries after the **Final Entry Deadline (2 JULY 2026)** must pay all applicable entry fees and hotel cancellation costs based on the original entries submitted. If these fees and costs are not paid, no member of that federation will be permitted to participate.

**Entry Fee**

The entry fees include all charges for registration, local transport between shooting range and official hotels, and anti-doping control.

Transferred amounts must be net of any bank fees. The payment status will be checked at the accreditation office, the missing payments must be paid in cash, card payment will not be accepted.

## Accreditation Process

All individuals involved in the Championships (Athletes, Team Officials, ESC/ISSF Officials, Organising Committee Officials, Media personnel) must have an accreditation card. This card must clearly identify the holder with a photograph, family name, first name, nation, and function, in order to use local transport and enter controlled areas at the shooting range.

**Pre-Registered Persons:** Accreditations for persons registered before the Late Entry Deadline and with a photograph in the ISSF database will be prepared by the Organising Committee.

**Late Registrations:** All other accreditations will be prepared by the ECH Accreditation Office.

Accreditations and BIB numbers will be distributed by the Organising Committee after the payment of all entry fees.

## 7. IMMIGRATION AND CUSTOMS REQUIREMENTS

Poland is a member of the European Union and Schengen Agreement. EU Nationals are able to enter Poland with a valid passport or with a valid ID Card. Countries, that require an Entry Visa for Poland should apply to the Polish Embassy/Consulate in their Country well in advance before the departure. Federations requiring an **Invitation Letter** for **visa** purposes must contact the Polish Sport Shooting Federation no later than **2 June 2026** by e-mail at: [oc@ech2026.pl](mailto:oc@ech2026.pl)

The Polish Sport Shooting Federation has no influence over embassy decisions and will only be able to provide invitation letters for the period of the European Championship and any official pre-event training. A visa cannot be guaranteed upon arrival at the airport or at the border. Each participating federation requiring a visa must complete the **Visa Support Form** (Annex 4) and return it to the Organising Committee within the specified deadline.

When **entering Poland**, participants must present an invitation letter and declare possession of their firearms to the police officer at the border, together with an official firearm owner's certificate. Persons holding a **European Firearms Permit** are required only to present the European Firearms Pass to the police officer and do not need to provide any additional documents or pay any taxes.

Persons arriving from outside the EU who do not possess a European Firearms Pass will receive an official form from the police when crossing the border, on which up to three firearms can be registered. The police will issue documentation for these firearms, which must be presented during check-in at departure and shown to the police officer.

Upon arrival in Poland, all firearms and ammunition must be **transported** directly to the **shooting range firearms storage**. At departure, firearms and ammunition must be collected from the firearms storage on the way to the airport (not earlier).

## 9. TRAVEL AND TRANSPORTATION

### Arrival

The **official airport** is **Wrocław Nicolaus Copernicus Airport** ([www.airport.wroclaw.pl](http://www.airport.wroclaw.pl)), located approximately 10 km from the city centre. If arriving at a different airport, please contact the Organising Committee for an individual offer for transport services.

Delegations **travelling by car** are requested to first arrive at the shooting range to store firearms and ammunition.

### Airport Transport – (Arrival and Departure)

The Organising Committee will provide transport services for all delegations between the official airport and the official hotels during the official days of the 2026 U23 European Championships plus one day prior (**31 July – 12 August 2026**).

Arriving delegations will first be transported to the shooting range to store firearms, ammunition and equipment. Afterwards, delegations staying in the official hotels will be transferred to their respective hotels.

After receiving all final travel forms and preparing the transport schedule, the Organising Committee will send an official notification to all delegations with confirmation of the airport pick-up and the contact details of the responsible person.

### Local Transport – Shuttle Service

The Organising Committee will provide transport services for all delegations between the official hotels and the shooting range during the official days of the 2026 U23 European Championship (**01–12 August 2026**).

Travel time between the city centre and the shooting range is approximately 30 minutes during periods of high traffic. The transport schedule will be published on the competition website, displayed on the information board at the range and available in the lobby of each official hotel. Meeting points will be clearly marked together with the schedule.

## 10. COMPETITION RELATED PROCEDURES

### Technical Meeting

The Technical Meeting will take place on **2 AUG 2026** at the Shooting Range **Finals Hall**. There will be a **separate Technical Meeting for Trap** on the day of Pre-Event Training (**7**

**AUG 2026**). Each participating ESC Member Federation is kindly requested to ensure that at least one representative is present to receive updated information regarding the **Final Competition and Training Schedules**, draw procedures, and other important matters related to the Championships.

The meeting times will be confirmed following the **Final Entry Deadline**.

### **Storage of Firearms and Ammunition**

Storage of firearms and equipment will be available at the **WKS Śląsk Wrocław** shooting range **free of charge**. All rifles and pistols must be stored from arrival until departure, except during repair, equipment control, training, and competition.

Firearms and equipment manufacturers with service facilities will be present during the official days of the European Shooting Championships. A list of companies will be published on the competition website.

### **Ammunition**

Ammunition can be purchased at the shooting range. The ammunition will be available at the prices varying from €15.00 to €20.00, depending on local distributor stocks. List of available ammunition:

## **11. CEREMONIES**

### **Award Ceremony**

The Victory Ceremonies will take place in the **Finals Hall** immediately following the conclusion of each final event or group of finals (see also: Final Competition Schedule).

During the Victory Ceremonies, athletes are required to present themselves in their official national uniform or national tracksuit (both top and bottom).

**Trap and Skeet Victory Ceremonies** will also be held in the **Finals Hall** according to the schedule.
