## Athlete Declaration U23/U18/U16 Category

1. I hereby confirm that I am aware of the rules and regulations of the International Shooting Sport Federation (ISSF) and the European Shooting Confederation (ESC), including the penalties in force for official ISSF and ESC competitions. This includes full acknowledgment of the rules relating to the fight against doping. I agree to submit to doping control tests, accept the results of such tests, and abide by the respective regulations in their prevailing form at any given time.
2. I agree that any dispute arising between myself and the ESC which cannot be settled amicably and remains unresolved after the procedures provided for in the ISSF and ESC Regulations have been exhausted, shall be settled exclusively by the Court of Arbitration for Sport (CAS) in Lausanne. This shall be in accordance with the Code of Sports-related Arbitration (CAS Code), and the parties undertake to comply with the CAS Code and accept in good faith the award rendered.
3. I acknowledge that my personal data (e.g., name, surname, date of birth, address and ID number) is being collected by the ESC and event organizing committees authorized by the ESC in connection with this declaration will be processed and used in accordance with the ESC Data Protection Regulation. By participating in ESC events, I agree to the collection, storage, and processing of my personal data for competition and administrative purposes.
4. I acknowledge that the ESC holds the international broadcasting rights for all events I participate in, including my personal data (e.g., image, likeness, name, voice, and declarations). By taking part in such events, I consent to this data becoming part of the ESC's international TV production. The ESC retains full rights to commercialize or license these events, without limitations of time, runs, language, or space.
5. I understand that all TV/ internet Streaming productions and related audiovisual material created during these events are the property of the ESC. The ESC retains full discretion to use, exploit, and commercialize these productions directly or through third parties, including TV rights holders, sponsors, and social media platforms. This material may be used for commercial and non-commercial purposes across various media platforms, including but not limited to:
  - TV channels
  - Social media
  - Websites
  - Editorials
  - Public relations
6. I acknowledge that ESC's international TV productions cover all activities during and connected to the competition, including but not limited to:
  - Competition and training at the shooting range

- Ceremonies
  - Warm-up areas
  - Athletes' lounges
  - Mixed zones
  - Any other event or location directly related to the competition (e.g., side events in the host town).
7. For the purpose of promoting shooting sport globally, I agree to make myself available for interviews with TV rights holders and ESC TV (or national host broadcaster) production teams in the Mixed Zone of the respective competition immediately after each Final, upon reasonable request.
8. I consent to the use of my photograph by the ESC for accreditation cards and to be posted on the ESC website as part of my athlete profile.
